1. We declare that we have read the contents of the prospectus/brochures/admission and fee policy and understood the contents fully. Having understood the information provided, we seek admission for our daughter into School in our own interest and accord.
2. We declare that all the information furnished by us in the application form is correct to the best of our knowledge, information and belief. We agree that in the event of any information found to be incorrect or false, admission may be refused and student may be debarred from the School and agree to abide by the policies, rules and regulations of the School, as amended from time to time.
3. We have gone through the schedule of fees and payment schedule of School. We agree to strictly adhere to the payment schedule. We will deposit the fees in full before the beginning of each term. The school fees and penalty, if any, which is due towards payment by us, will be paid within 30 days. If we default in making the payment, we are aware that, we will be asked to withdraw our ward. We will accept such a decision of the school authorities. The School reserves their right to struck off the name of ward from its rolls on non-payment of timely fees.
4. We will not ask for any refund of fees if our ward is expelled from the School on disciplinary grounds or is withdrawn during the session by us or any reason whatsoever. We understand that a fee once paid is non-refundable in all circumstances. In case of the student's discontinuation of study, we understand that a full fee for the entire year has to be paid before collecting the original transfer certificate.
5. We shall pay promptly and whenever called upon to do so, additional charges if any, relating to the education of child or for extracurricular activities/ trips/ Educational Learning Journey/specialized professional/ extra coaching etc. as per norms prescribed/to be prescribed by the School.

We understand that my ward may be expelled/removed from the school for indulging in (i) unfair means in any examination; (b) consistent unsatisfactory progress; (iii) immorality; (iv) grave insubordination; (v) stealing of money and/or items from other students; (vi) damaging school property; (vii) any word or action likely to undermine the reputation of the institution; (viii) bullying, assaulting and ragging in any form; (ix) smoking, alcohol & use of other psychotropic drugs and substances.
  
7. We understand that no leave will be granted to my ward unless approved by the Principal. The gate pass will be issued only to us or to the authorized local guardians to take our ward, out of the school premises during weekend outings/ leave for special occasions.
  
8. We shall ensure that our ward will report back to the School on the assigned date as mentioned in the leave application. She will join back on the day the School reopens after vacations as per the dates specified in the School calendar. We understand that if our ward fails to join back on the assigned date, necessary disciplinary action may be taken against her.
  
9. We undertake and agree that if our ward leaves the school campus without written permission, the school authorities may lodge an F.I.R. with the local police station and we will have no right to question and raise objections to this action. The School will not be responsible for any mishap in such circumstances.
  
10. We shall ensure that our ward does not carry any type of gadgets/ mobile phones/ intoxicants/electronic games/pen drive etc., during her presence/stay in the School.
  
11. The School shall not be responsible for any loss, damage or theft of personal properties belonging to our ward within the School premises or during School programmes, trips, excursions and travel to and from the School.

That the School shall not be liable for any damages for any injuries, fatal or otherwise, which may be sustained by our ward whether within or out of the School premises, while taking part in sports, extracurricular or any other form of activity of the School. The consequences and the expenses that may be incurred from such injuries shall be borne by us.

15. We agree to accept the Medical Insurance Policy which the School will enter into agreement with the Insurance Company. In the event of an emergent requirement of surgery/treatment, we permit the School authorities to take appropriate action. We assure that the local guardian will immediately rush on information and duly sign all the required medical papers on our behalf. We agree to reimburse all the medical expenses incurred by the school authorities during the course of treatment which are not covered under the Insurance policy. The School shall not be held liable and responsible in any manner whatsoever.
16. We will inform the School authorities about any change in our documents including home address or telephone numbers immediately after the change for updating the records.
17. We agree to my child's name and/or photograph/video appearing in any of School's brochures, prospectus, publications, media such as internet, TV, newspaper etc. without the need for any prior approval from us.
18. We assure our full co-operation to the School authorities in the interest of my ward.

We agree that in case any dispute or difference arises out of or in connection with the interpretation or implementation of this Undertaking, then the dispute shall be resolved under Arbitration and Conciliation Act, 1996. The dispute shall be referred to a Sole Arbitrator who shall be appointed by Principal of School. The seat of arbitration shall be at Mussoorie and shall be conducted in English. The courts at Dehradun shall have jurisdiction.
